The Nova Scotia Carpenter Millwright College is experiencing a busy fall, thanks to a full Carpentry Development Program, a well attended 11-week UBCJA Scaffolder Program, Forklift, Telehandler, Mobile Elevated Work Platform, Fall Arrest, Confined Space Programs and more! Thanks goes out to all our Carpenter and Millwright brothers and sisters for taking advantage of the great training programs we offer.

This fall, we are piloting a NEW Industrial Solar Farm Rack and Panel Installation one-day program, as well as Insulating Concrete Forms one-day. Since the high schools are back in session, the CMC has started taking

bookings for one and two day Construction Trade themed programs for high school students that happen right here in our facility. For example, in the 2018-2019 school year, your CMC hosted 36 separate days of High School students learning the basics in Carpentry, Drywall, Scaffolding and more. This is our way of doing what we can to encourage young people to get into the trades, as well as potentially gain some great new members for our Carpenter and Millwright Locals!
