Organizing Team

Nose to the grindstone is an understatement when describing the work our organizing team has been putting in during this global pandemic. In August of this year, Local 579 filed a union certification application at the Labour Board on Grieg NL. The days that followed resulted in; a breach of members' confidentiality by the Labour Board; our union filing a complaint on our members' behalf at the Office of the Privacy Commissioner; and the subsequent filing of an unfair labour practice complaint. A hearing date is expected to be scheduled in the coming days. In the meantime, your union leadership will continue to hammer away to look for fair representation for workers, increased industry representation at the Labour Board and changes to the Labour Relations Act to bring us up to a level with the rest of our country. Now more than ever, it is vital for our union to pull together and support our organizing team as they strive to reach the UBC goal to achieve 70 percent of market share in the crafts we represent. Every company that is unionized, increases market share and this means more jobs for our members. There are currently two active applications filed at the Labour Board.

Federal Government Programs

There have been a number of inquiries from members regarding qualifications for Employment Insurance Benefits. The Government of Canada has made some changes to existing programs as the CERB program ends.

Simplified Employment Insurance: Individuals with a minimum of 120 hours of work, claimants will receive a one-time insurance credit to bring them up to 420 hours so that they qualify for El. The hours credit will be retroactive to March 15th. Claimants will receive a minimum of \$400 per week. Minimum entitlement of 26 weeks regular benefits.

Canada Recovery Benefit: Individuals who are not eligible for El, can receive \$400 per week for up to 26 weeks. To qualify, individuals had to have employment income of at least \$5,000 in 2019 or 2020. Workers would have to apply after every 2 week period.





Carpenter Millwright College Well Trained. Work Ready.

With the ongoing COVID -19 crisis impacting all aspects of how we work and learn, CMC Newfoundland and Labrador took a different approach this year with our fall enrollment. In addition to our safety members, we had over 40 new students register for our Pre-Employment Carpentry and Industrial Mechanic programs; all arriving on September 8th to start their training.

In the past, all students arrived as one large group to register for their programs and then continued to an orientation, lunch, and a tour of the College. With lots of planning from our Administrative staff, we had the students preregister through one-on-one meetings with our administrative personnel. The students were then preassigned classes for their arrival on September 8th. Tours and lunch were staggered and completed in classroom "bubbles" in accordance with standard safety measures (physical distancing & masks). All students were also required to read our COVID Recovery Policy and our Student Manual prior to attending the College. This process took a lot of planning and preparation, but in the end proved to be more efficient and will continue in the future.

We also give weekly surveys to all students and staff to gauge how CMC is doing with our COVID safety measures. The feedback will let us know what we are doing well or where we need to improve. To date the survey results have indicated that the registration process made everyone feel comfortable and safe.
